WILLIAMSFIELD PUBLIC LIBRARY DISTRICT
BUDGET & APPROPRIATION ORDINANCE

Annual Budget and Appropriation for the WILLIAMSFIELD PUBLIC LIBRARY DISTRICT for the fiscal year commencing **July 1, 2023** and ending **June 30, 2024**.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE WILLIAMSFIELD PUBLIC LIBRARY DISTRICT, Knox, Peoria and Stark Counties, Illinois, as follows:

SECTION 1: The following sums of money or as much thereof as may be authorized by law and as may be needed, which are deemed necessary to defray all necessary expenses and liabilities of the WILLIAMSFIELD PUBLIC LIBRARY DISTRICT, be and the same are hereby budgeted and appropriated for the corporate purposes and objects of the said WILLIAMSFIELD PUBLIC LIBRARY DISTRICT, hereinafter specified for the GENERAL CORPORATE FUND, MEMORIAL FUND and SPECIAL RESERVE FUND for the fiscal year commencing on the **1st day of July, 2023** and ending on the **30th day of June, 2024**, that the estimate of the receipted expenditures and total amount appropriated for each corporate object and purpose for each fund is set forth hereinafter:

SECTION 6: Each appropriated fund total is divided among the several objects and purposes specified and in particular amounts stated for each fund respectively in Section 5 constituting the total appropriations in the amount of **Three Hundred Forty-six Thousand One Hundred Dollars (\$346,100.00)** for the fiscal year beginning **July 1, 2023** and ending **June 30, 2024**.

SECTION 7: Any unexpended balance of any times of any appropriations made by this Budget may be expended in making up any insufficiency in any other items of appropriations made by this Budget upon approval of the Board of Trustees.

SECTION 8: Any sum of money heretofore appropriated and not heretofore expended and now in the treasury of said Library District or that may hereafter come into the Treasury of said Library District by way of State Regulations, State Income Taxes, or Grants, or Federal Grants, Fines, Judgments, Claims, Investments or Gifts is hereby appropriated by this Budget.

SECTION 9: The invalidity of any Section or portions or items of this Budget shall not effect the validity of any other portion thereof or the appropriation for any item or Fund which be given effect without such valid parts.

SECTION 10: The Secretary of the WILLIAMSFIELD PUBLIC LIBRARY DISTRICT is hereby authorized and directed to publish this Ordinance at least once in the KNOXVILLE BULLETIN, a newspaper published in Knox County and having general circulation in the district.
